GUIDELINES

- Photos are to be inspired by the theme: "To everything there is a season, a time for every purpose under heaven...." Ecclesiastes 3:1-8
- Individuals must submit their own work.
- All photos must be 8" X 10" matted using a BLACK matte with an 8" X 10" opening and attached to foam board or poster board.
- Entry forms are to be attached securely to the back of mounted photo.
- The photographer's name may not be displayed on the front of the picture.

CATEGORIES

Photos will be judged in 2 categories:

- 18 years & under
- Over 18 years

JUDGING

There will be a closed judging prior to the exhibition..

AWARDS

Awards will be given in each division: \$150 for 1st Place, \$100 for 2nd place and \$50 for 3rd.

EXHIBIT

The 2010 Photos of Faith entries will be exhibited June 10th, 11th, and 12th at New Haven United Methodist church.

CONTEST DEADLINE

The last day that photos and entry fees will be accepted for the competition is **Friday, May 7, 2010.** (All entries must be postmarked by that date.)

CONTEST FEES

Each photo entry is \$5. Multiple entries are allowed, but separate entry forms and entry fees must be included with each.

Fees can be paid in the form of check, cashier's check, or money order made payable to New Haven United Methodist Church. All contest fees are non-refundable.

LIABILITY

Utmost care in handling will be given to all entries. However, the Photos of Faith Contest & New Haven United Methodist Church cannot assume any responsibility for the damage or loss of entries in transit. NHUMC shall assume the right to reproduce any entry. It is the photographer's responsibility to secure the necessary releases from identifiable persons shown in all images. Contest participants must complete the release portion of the official entry.

RECLAIMING PHOTOS

Photos may be picked up at New Haven United Methodist Church on or after Monday, June 14, 2010 during office hours. Photos will only be returned by mail if a self addressed, stamped mailer is included with adequate postage. New Haven United Methodist Church is not responsible for damaged or lost mail. Entries that are not claimed by July 16, 2010 will become the property of New Haven United Methodist Church.
